Time flies, but it is that time again. This is a friendly official reminder/notice that your completed Campaign Finance Report (C/OH) is due on Thursday, July 15, 2021, by 5:00 P.M. at the Office of the City Secretary. As a candidate or officeholder, you alone, not the campaign treasurer, are responsible for filing this form. Failing to file a report on time or filing an incomplete report may subject you to criminal or civil penalties. State law does not impose any reporting or record-keeping obligations on a candidate's campaign treasurer. The Office of the City Secretary is the filing authority ONLY, so we cannot comment on the completeness or accuracy of the report. It is the candidate's or officeholder's responsibility to ensure that the form is complete and accurate.
